WHAT IS THIS PRODUCT?

Type: This product is a share class (R) of a sub-fund (Dynamic Asset Allocation) of an investment company with variable capital (SICAV) under Luxembourg law (Candriam L), Undertakings for Collective Investment in Transferable Securities (UCITS).

Term: Open-ended.

Objectives:

Principal assets traded:

Equities, bonds, cash, money market instruments from all types of issuers on the global markets, through investment funds and/or derivatives.

Investment strategy:

The fund seeks to achieve capital growth through diversified investment, prioritising equity funds, and to outperform the benchmark.

Within the limits of the fund's investment objective and policy, the management team makes discretionary investment choices in the portfolio based on analyses of the characteristics and growth prospects of the assets traded. The proportion of net assets invested in equities will in principle be a majority. However, it may be strongly reduced depending on the manager's expectations regarding movements in the financial markets and in order to reduce the risk to the investor. Neutral weighting in equities in the portfolio is therefore about 75% (the neutral weighting is the theoretical proportion of the fund assets invested in equities, using which the management team determines the distribution of fund assets on the basis of its market expectations).

The fund promotes, among other characteristics, environmental and/or social characteristics but does not have sustainable investment as its objective. The analysis of ESG (environment, social, governance) aspects is integrated in the selection and global allocation of the underlyings. As a result, the fund invests at least 75% of the net assets in funds which themselves have sustainable investment as their objective and/or promote, among other characteristics, environmental and/or social characteristics. The Fund also aims to exclude investments in companies which do not respect certain recognised international standards and principles, or which are significantly exposed to certain controversial activities. In certain conditions, the analysis and selection process may be accompanied – where applicable indirectly through the underlying fund(s) – by active involvement, in particular dialogue with companies and voting as the shareholder at AGMs. For more information, please see the management company's website and/or the prospectus.

The fund may make use of derivative products for both investment and hedging purposes (to protect against future unfavourable financial events). **Benchmark:** 25% Bloomberg Euro-Aggregate 1-10 Year Index (Total Return) + 22.5% MSCI EMU (Net Return) + 22.5% MSCI World ex Europe (Net Return) + 18.75% MSCI Europe ex EMU (Net Return) + 11.25% MSCI Emerging Markets (Net Return).

The fund is managed actively and the investment approach implies a reference to a benchmark (the index).

Benchmark definition:

Bloomberg Euro-Aggregate 1-10 Year Index: measures the performance of EUR denominated investment grade bonds with a maturity of 1 to 10 years. MSCI EMU: measures the performance of the large and mid capitalisation equity segment in developed markets in the European Economic and Monetary Union (EMU).

MSCI World ex Europe: measures the performance of the large and mid capitalisation equity segment in developed markets (outside Europe).

MSCI Europe ex EMU: measures the performance of the large and mid capitalisation equity segment in countries with developed markets in Europe (outside the European Economic and Monetary Union).

MSCI Emerging Markets: measures the performance of the large and mid capitalisation equity segment across countries with emerging markets. Use of the benchmark:

- in determining risk levels / parameters,
- to compare performance.

Divergence of portfolio composition from the benchmark:

As the fund is managed actively, it does not aim to invest in each component of the index nor to invest in the same proportions as the components of the index.

In normal market conditions, the expected tracking error of the fund will be limited to moderate, namely between 0.5% and 3%.

This measure is an estimation of the divergence of the fund's performance compared to the performance of the benchmark. The greater the tracking error, the greater the deviations from the benchmark index. The actual tracking error depends in particular on market conditions (volatility and correlations between financial instruments) and may therefore differ from the expected tracking error.

Repayment of shares: On demand, every day, in Luxembourg.

Allocation of income: Reinvestment.

This product is for investors who meet the conditions for accessing the product in question (see prospectus) with any level of knowledge and experience who are looking for Capital Growth. This product can be used as a core holding or a component of a diversified portfolio for investments with an investment horizon of 5 years. 

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a mediumlow risk class.

This rates the potential losses from future performance at a mediumlow level, and poor market conditions are unlikely to impact the capacity to pay you.

WHAT HAPPENS IF CANDRIAM IS UNABLE TO PAY OUT?

As the Funds' assets are held with the depositary, they are not part of the assets of Candriam in case of bankruptcy and cannot be seized by the creditors of Candriam. Nevertheless, investors run the risk to suffer a financial loss in case of the default of Candriam.

In case of default of the depositary, the risk of a financial loss is mitigated to some extend as the Fund's assets are legally segregated from the assets of the depositary.

The potential financial loss associated with the default of Candriam is not covered by an investor compensation or guarantee scheme.

WHAT ARE THE COSTS?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period:

5 years

The choice of recommended holding period depends on the types of the underlying investments and on the associated degree of risk, which may be higher or lower. For example "equity" type products (higher risk) generally have a recommended holding period of six years (long term), and "bonds or money market" type products (lower risk) have a shorter recommended holding period (generally between two and four years for bond products or less than one year for money market products - medium term/short term). "Mixed" type products generally have a recommended holding period of between three and five years depending on the weighting of the types of underlyings. "Alternative" type products generally have a recommended holding period of three years.

Investors may request redemption of their units at any time under the conditions set out in "What will this investment cost me?". The shorter the holding period in relation to the recommended period, the greater the potential impact of any charges on the performance profile.
