With over €23 billion of assets under management (AUM)¹ across this integrated platform, the core objective is to optimise synergies between each specialised team, aiming to deliver consistent positive returns across various market cycles. Candriam will also be increasing its efforts in ESG integration within its alternative investments and looks forward to launching new innovative ESG-focused absolute return solutions, furthering its dedication to responsible investing.

To lead this newly unified division, Candriam has appointed Steeve Brument to the role of Global Head of Alternatives. Steeve, previously Head of Multi Asset Quantitative Strategies and Deputy Head of Multi Asset at Candriam, has held a 25-year career in the industry, including a 20-year track record as fund manager at Candriam. In this new role, Steeve will work with a team of 34 investment professionals dedicated to alternative investment solutions. Steeve will report directly to Nicolas Forest, CIO at Candriam. He will also become a member of Candriam's Executive Committee.

Candriam's alternative investments platform is further complemented by its alternative credit strategies, which are part of its broader fixed income offering. This approach capitalises on cross-departmental strengths, fostering synergy and innovation in its investment solutions.

#### **Steeve Brument - Global Head of Alternative Investments**

Steeve Brument was appointed Global Head of Alternative Investments in November 2023. Previous to this Steeve was Head of Quantitative Multi-Asset Strategies since 2019. He started his career in 1997 within the private client group of Merrill Lynch before moving to Refco Securities in the Futures and Equity Derivatives Division in 1999. He joined Candriam as a Systematic Fund Manager in 2001 and did extensive research on trading systems and systematic portfolio allocation. In 2007, he became Head of Systematic Funds, and diversified its CTA from traditional trend following models, to a mix of trend following, pattern recognition and counter trend models. Steeve has had leadership roles in overseeing several strategies such as global macro, long short equity and alternative multi strategy funds. Steeve holds a master's degree in Finance from the PSB Paris School of Business.

### **Grégoire Thomas - Head of Equity Market Neutral**

Grégoire Thomas joined Candriam in December 2023 as Head of Equity Market Neutral. Grégoire has an in-depth expertise in index arbitrage and market neutral strategies including in his prior role as a Portfolio Manager at Millennium in Paris and during his time as Managing Director at Bank of America for Equity Synthetics & Securities Lending, both in the EMEA region and Asia. Previous to this he had various leadership roles at Société Générale, including Managing Director of Securities Finance & Delta One and Head of Asia-Pacific Delta One Index Trading.
