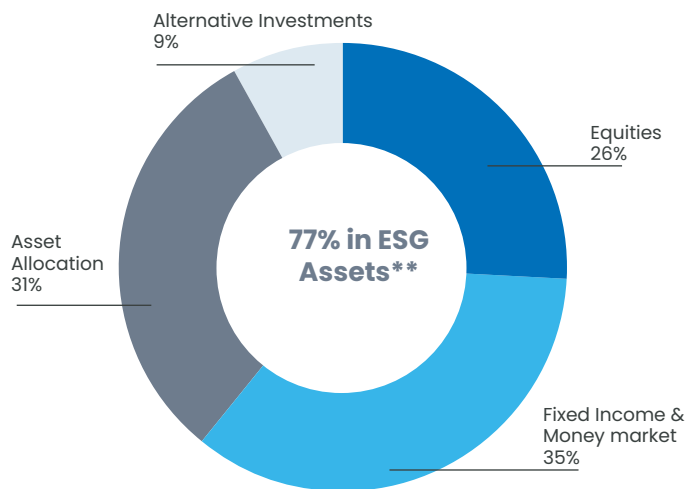

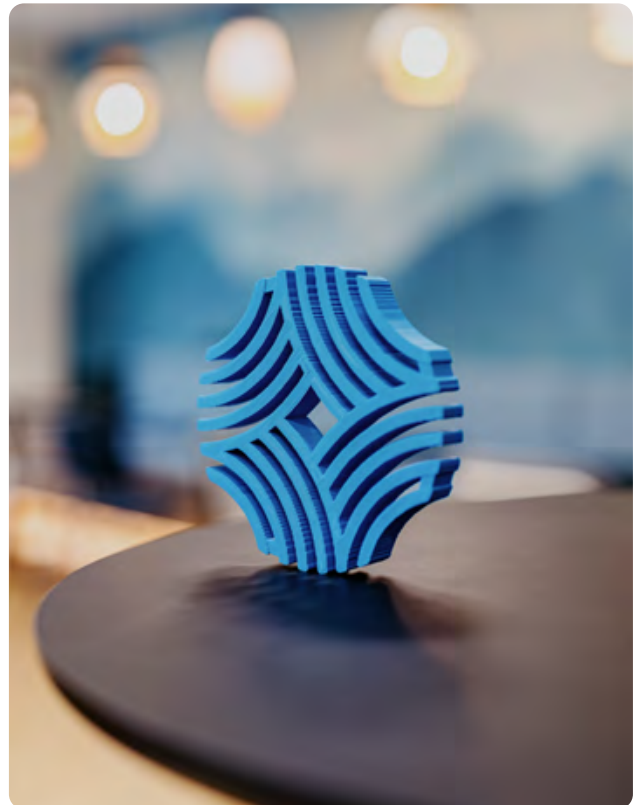

Strong and independent research is one of the cornerstones of our sustainable approach. Our team of ESG experts has developed a conviction-led proprietary approach which involves:

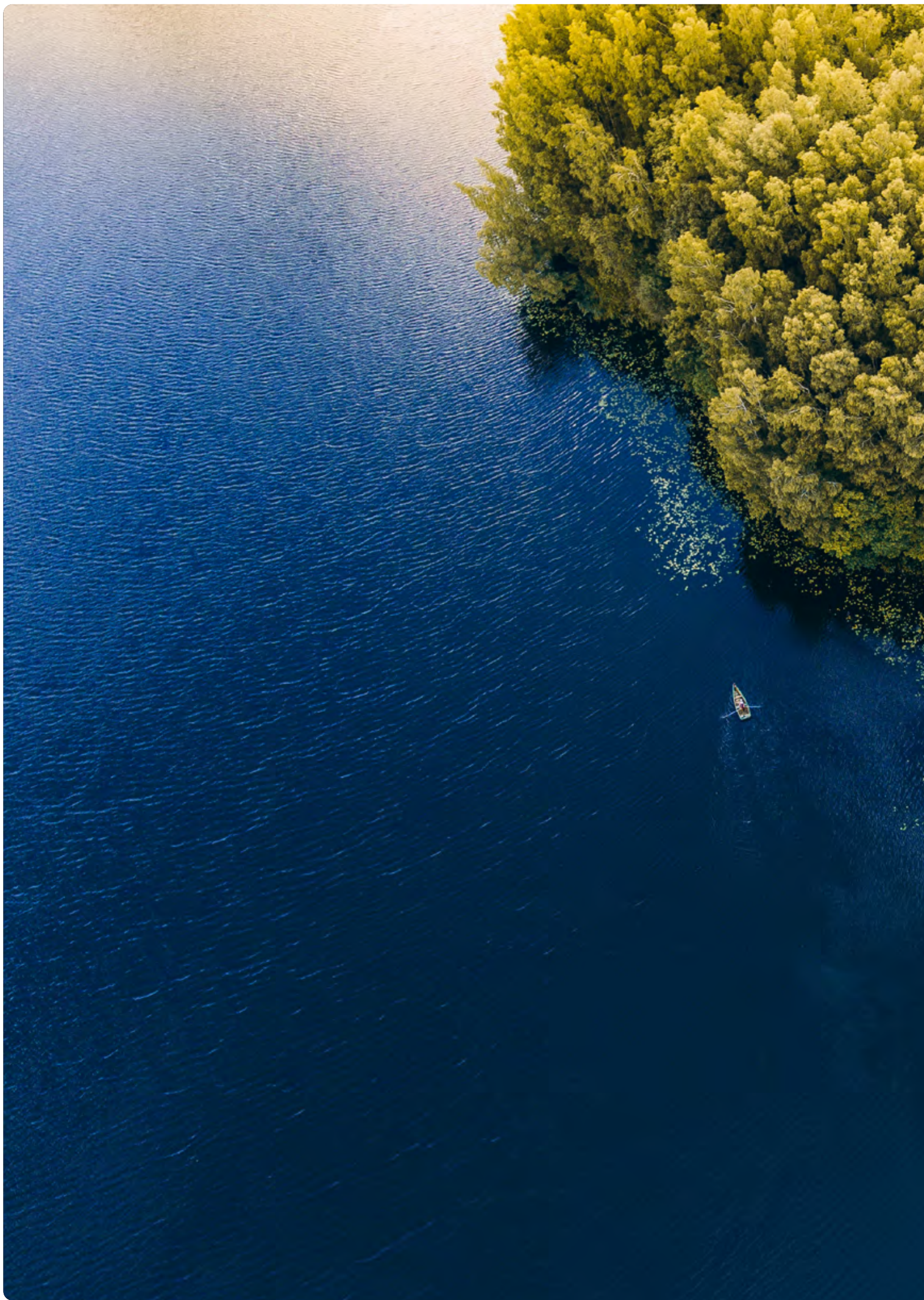



- Selecting firms with leading ESG practices.

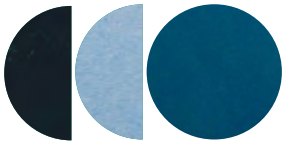
We believe that sustainable investing is a source of added value and can contribute to shaping a better world.

We play our part in shaping the world we want to live in, a world where we take care of the environment and include all stakeholders, clients, providers, employees and communities.

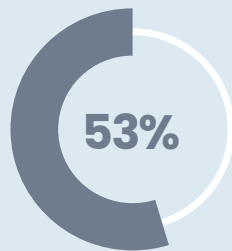

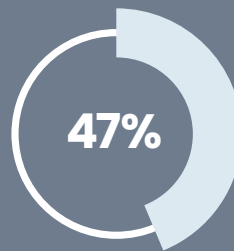

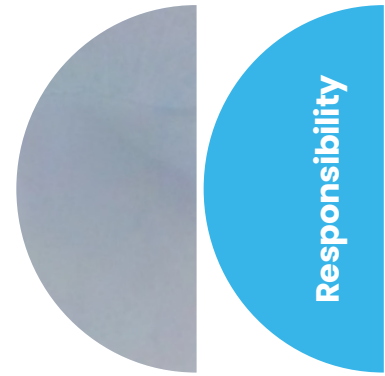

The Candriam Institute for Sustainable Development, funded by Candriam and run by its staff, targets more specifically seven of the UN Sustainable Development Goals along four themes:
